2nd ARPA Distribution Update

In 2021, the Department of Community and Economic Development (DCED) successfully allocated funding made available to **Pennsylvania municipalities from the American Rescue Plan Act (ARPA)**. A majority of municipalities accepted the ARPA funding. Those PA municipalities that received the First Tranche of ARPA funding should receive the second and final program payment **the week of Sept. 12**. Those funds should be in the account DCED has on record and should match what was received in the First Tranche. Recipients of these funds may use the funds for projects **outlined in the ARPA guidelines**.
